RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of being permitted to enter the Great Gurnee Adventure organized by the Gurnee Days Corporation, of Gurnee, IL and use of property, facility and services of the Village of Gurnee, and the Gurnee Park District for the event, I agree in exchange for being permitted to compete, observe, work for, or for any purpose participate in any way in the event, THE UNDERSIGNED, acknowledges, agrees and represents that he/she has, or will immediately upon entering any area of the event, and will continuously thereafter, inspect such event areas and all portions thereof which he/she enters, and he/she does further warrant that his/her entry upon such event area or participation, if any, in the event constitutes an acknowledgement that he/she has inspected such area and finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about event areas and feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the event areas. Further, THE UNDERSIGNED:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the sponsor, participants, or any subdivision thereof of the event and each of them, their officers and employees, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the event area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event;
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the event area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the event area and/or while competing, officiating, observing or working for or for any purpose participating in the event.

THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are dangerous and involve the risk of injury and/or property damage. THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and

indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Illinois in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
